Please accept this as written confirmation that Louis Schamroth-Green and Louis Morgan from SuperMassive will be supporting Will as part of his proposed NLPG grant activities, running June 2026 - October 2026.

I am Creative Director of SuperMassive, an immersive arts company producing large-scale interactive works for festivals, events, and gallery environments. Our most recent project ran at Depot Mayfield, Manchester (June - December), where across the 75,350 sq ft site we produced a 14-room immersive experience for which Will was commissioned as Narrative Lead. Will's narrative style of world building appeared to us as naturally expandable to immersive environments and the commissioned work has proved a great fit for the experience. He has worked seamlessly alongside the creative technologists and AV technicians supporting the install. We have every confidence, given his experience and work to-date that the R&D will bring about results beneficial not only to his practice, but the wider makers community and the audiences he intends to reach beyond the R&D.

In my capacity as Project Consultant, I will provide oversight on early-stage project management and, during the lab period, direct support with TouchDesigner integration, physical outputs, and prototype refinement. I will also consult on experiential aspects of the work, including future audience considerations, design efficacy, scalability, and broadening access.

Louis Morgan is a senior coding engineer and systems architect at Supermassive with specialist experience in LLM API and multi-room infrastructure, directly aligned with Will's R&D goals. He is uniquely placed to help Will establish a robust codebase architecture he can continue to operate and build on independently beyond the R&D period.

We have both agreed a concessionary rate of £350/day and a fee of £100 per 90 minute consultancy call. The reduced rate reflects our genuine interest in the project and confidence in its outcomes. This is an original and exciting proposal, and we sincerely hope the NLPG supports Will in carrying it forward.

I am a freelance access consultant working across live events, arts and culture, drawing on a background as strategic access lead at Factory International and Manchester International Festival as well as lived experience.

Having reviewed the project outline, I am genuinely excited by the work Will is proposing. The combination of comedic-satirical narrative, spatial audio, and interactive AI systems feels both timely and distinctive and is exactly the kind of thoughtful, accessible experimentation I believe the sector needs more of. Will's background as narrative lead on Supermassive's Depot/Mayfield installation gives the project a strong grounding, and the R&D framing is well-suited to the scope and ambition described.

I look forward to contributing to this project and wish Will every success with the application.

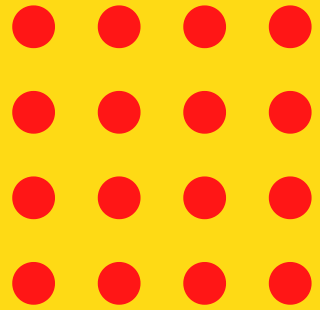

To whom it may concern,

I confirm I will be available to support Will on his NLPG project proposal in my capacity as a qualified sound engineer (MA Sound Engineering) with accreditation in spatial audio / dolby atmos.

I have previously worked as a mix and master engineer with Will supporting him with his Resonance FM series. Over the course of our collaboration we have developed a project pipeline adapted to his processes. With this working relationship established, integration of atmos / surround elements will operate as a seamless extension of our developed processes.

Understanding the cultural value Arts Council brings to communities and the reach, access and possibilities these grants offer - I have agreed with Will a revised down day rate of £220/day to assist him in realising spatial audio outputs at the prototype stage.
